#### **Course Description:**

Concentrate on the essentials of dressmaking, including the basic sewing skills, selection of a pattern and materials, taking measurements and the steps involved in constructing a simple skirt. Construction techniques for other skirt styling are also covered.

#### **Vocational Learning Outcomes:**

Upon successful completion of this course, the student will be able to:

- 1. Choose, read, layout and adjust/alter and cut a skirt pattern.
- 2. Complete and apply appropriate body measurements and relate to the pattern pieces.
- 3. Demonstrate safe and proficient use of domestic (single needle) sewing machines, applying suitable construction threading, sewing skills, tensions and settings.
- 4. Apply pressing techniques appropriate to fabric type and application.
- 5. Construct a skirt (waistband, zipper, darts) in a step by step fashion.
- 6. Complete a set of samples that can be used for reference.

10	Final quiz and finishing of skirts;
